## Gutter Protection Systems

### INSTALLATION INSTRUCTIONS

#### Installation Instructions

1. Clean gutters to ensure they are clear of any debris.
2. Check the condition and pitch of gutters. If the gutter condition is poor or the pitch of the system toward the downspout is not at least 1" of decline for every 16' of gutter, be certain to make the homeowner aware, as this could create a water flow challenge completely unrelated to the installation of gutter protection.
3. Always be certain to place the Leaf Defier inserts into the gutter, ensuring that the top coated surface is facing upwards.
4. Install miters first and work outwards from them. Mitered sections will perform best if supported by a full 4 foot section leading into the area as miters bear the most stresses.
5. Inside and outside miters must be cut on an angle in order allow for unimpeded water flow. Improperly cut miters may leave too much Leaf Defier material in the open cavity of the mitered area and flow-over may result from heavy rains. Miter boxes should be utilized as they provide the proper angles and it is best to use a cutting instrument with a long blade to ensure straight, uniform cuts.
6. Utilize under-the-hanger (UTH) or over-the-hanger(OTH) installations where most appropriate. When gutter hangers are situated low in the gutter, OTH installation is recommended. The reason to consider OTH installation is that when the Leaf Defier material is compressed too much beneath a hanger, the flow rate of the gutter system can be impeded and flow-over may result from heavy rains. In addition, OTH installation is recommended to avoid creating too much room for debris to collect above the material where it is held down beneath a low hanging bracket.
7. When brackets are situated at the top/upper level of the gutter, it is most appropriate to install the insert UTH. Slide each insert under the spikes or hangers and pull it to length. All 4' sections must be compressed a ¼ inch against the next which is a total of ½ inch compression between adjacent sections.



**CAUTION:** Gutters can have sharp edges. Wear gloves while installing this product.

**CAUTION:** Installation of this product may require the use of a ladder. Read and follow the ladder manufacturer's safe use instructions. Use the appropriate sized ladder for the job. Use extreme caution when carrying anything on a ladder. Failure to follow all instructions and warnings may result in serious injury.

**REGISTERED 25-YEAR WARRANTY**

Monzi, LLC ("Monzi") manufactures Leaf Defier® Gutter Protection System (the "Product") in accordance with high standards and tight quality controls.

**WHAT DOES THIS WARRANTY COVER?** *Manufacture:* Monzi warrants to you, the owner of the property, at the time the Product is installed that the Product is free from defects in material and workmanship in the course of manufacture, and the Product will not chip or blister under conditions of ordinary wear if installed according to our installation instructions. This Warranty is limited to the terms and conditions, exclusions and limitations, requirements and legal rights stated in this Warranty. *Performance:* Monzi warrants to you, the owner of the property at the time the Product is installed, that when installed in the manner specified by Monzi, the Product will keep the interior of your gutters from becoming clogged and overflowing as a result of the gutter or downspouts filling with debris such as leaves, twigs, needles, or seeds. This Warranty is limited to the terms and conditions, exclusions and limitations, requirements and legal rights stated in this Warranty.

**HOW LONG DOES THE COVERAGE LAST?** This Registered 25-Year Warranty is for twenty five (25) years on the property where the Product is originally installed ("Property"). This Registered 25-Year Warranty may not be transferred or assigned. Under no circumstance is the Registered 25-Year Warranty more than 25 years from the date of original installation of the Product on the Property.

**WHAT WILL WE DO?** You must notify us as outlined below and we must validate the claim. Upon the notification and validation, we will undertake the following: If there is a defect in the manufacture of the Product, or the Product fails to perform as stated, at our sole option, we will repair, replace or refund the purchase price or a portion thereof of the originally installed Product. In the event that we choose to replace the Product, we will only be responsible for providing materials, and will not be responsible for the cost of labor to install new Product. We will not be responsible for any cost or expense to clear any blockage or obstruction which is determined to be below grade. In no event will our obligations under this Warranty exceed the suggested retail price of the originally installed Product found to be defective. Any additional costs and expenses beyond these amounts are your responsibility. In the event of repair or replacement under this Warranty, the Warranty applicable to the replacement material or to the repaired Product will extend only for the time remaining under the original Warranty.

**WHAT DOESN'T THIS WARRANTY COVER?** This Warranty does not cover: damage of any kind resulting from faulty or improper installation; changes in surface color resulting from chalking, fading, soiling or staining; exposure to the elements may cause these changes over time; the degree to which weathering occurs will vary depending on air quality, the building's location and other local conditions over which we have no control; accidental damage; settlement; structural shrinkage or distortion of the property structure; fire; lightning, hurricane, tornado, windstorm, earthquake, hail or other acts of God; harmful chemicals (including harmful cleaning compounds and pesticides); fumes or vapors; surface deterioration due to air pollution; misuse or abuse; vandalism; airborne stains, mold and mildew accumulation; any cost or expense incurred to clear any blockage or obstruction which is determined to be below grade; impact of foreign objects; warping or distortion due to exposure to excessive heat sources (e.g., barbecue grills) or exposure to unusual or excessive reflective heat sources (e.g., skylight or window reflection, roofing materials, pools, decks, blacktop or concrete materials); products that have been painted or whose surface has been altered in any way without written authorization from Monzi; damage of any kind resulting from water flow caused by non-removal of debris located in areas where air can not lift away debris, such as in a sheltered roof area or overhand on a shallow pitched roof; damage of any kind resulting from failure to undertake care and maintenance of Product as provided for in the attached warranty documentation; or any other causes beyond our reasonable control.

The Product must be installed in accordance with the Installation Instructions, a copy of which are included herein and are available on our website at <http://www.leafdefier.com>. **THIS WARRANTY IS NULL AND VOID IF THE PRODUCT IS NOT INSTALLED IN ACCORDANCE WITH THE INSTALLATION INSTRUCTIONS. FAILURE TO COMPLETE THE WARRANTY REGISTRATION APPLICATION IN FULL WILL PREVENT REGISTRATION OF THE WARRANTY AND THE WARRANTY WILL BE NULL AND VOID. WE EXCLUDE AND ARE NOT LIABLE FOR ANY DAMAGES TO PROPERTY OR PERSON WHICH ARISE OUT OF IMPROPER INSTALLATION OR FAILURE**

If, for any reason, Products of the type originally installed are no longer available from us at the time you make a Warranty claim, we may substitute another product determined by us to be of comparable quality and price.

**CARE AND MAINTENANCE** In most cases, normal debris is lifted away with a gentle breeze. In certain circumstances, debris may collect where air cannot lift away debris. These areas must be cleared to keep the Leaf Defier product working properly.

**HOW DO YOU REGISTER YOUR WARRANTY?** For all Leaf Defier materials used on this installation project, an Application for Warranty Registration must be completed and mailed within thirty (30) days after original installation has been completed. Failure to register the Warranty will void the Warranty. Registration of this Warranty confirms the date of purchase of our Products and assists Monzi in processing any Warranty claim you might have.

**HOW DO YOU SUBMIT A WARRANTY CLAIM?** You must submit your claim in writing to us within the Warranty period and within forty five (45) days after the defect is discovered. To initiate a claim, you should contact our Warranty Services Department at Monzi, LLC, Warranty Claims Department, 220 Anderson Ave., Moonachie, NJ 07074 to receive a Warranty Claims Packet. Any and all warranty claims shall be governed by and construed in accordance with the laws of the State of New Jersey, without reference to the choice of law doctrine. Any proceedings in response to disputes with respect to the Warranty hereunder shall be held within the State of New Jersey.
